5. Club Chairman's Report on the Club's Development throughout the 2023/24 season

Kevin Falvey thanked everyone for attending the AGM and apologised for the meeting being held again 2 months later

than our pre covid schedule. KF stated that he will endeavour to make this meeting as quick and painless as normal.

KF thanked the Junior Section Chair and Vice Chair – Nick Harwood and Sharon Taylor together with the junior coaches

and committee, who have seen us through another challenging season.

Sharon has stepped down as Vice Chair of the Junior Section and I thank her for her service and commitment, but mostly for her organisational skills over the period of her tenure. The junior awards evening has never run so smoothly

or to time in all my years of attending.

A number of senior players together with Kieran continue to help with coaching within the junior setup.

Catering has worked well, with Kathy on Sunday mornings at Bredon and the volunteer rota seemed to work at Westie

under the control of Sharon.

As for the Bar, then with the attempt at a paid manager failing at the first hurdle, then Gemma and Duncan both

stepped up and kept things flowing ably supported by the paid and volunteer teams who have again done a sterling

job.

However, it's great to report that Daz and Kemps have been appointed to running the clubhouse going forward and

Gemma continues to be a great asset.

Our 3rd year with O'Neill's as our merchandising partner has gone well. The club kickback this year has not as yet been

spent, but I would like to get kit for the Ladies section, perhaps socks / shorts/ leggings etc.

It is good to see players and supporters alike wearing club colours on match days and while out and about in general.

It is good advertising for the Club. Remember we still sell other items over the bar.

We have a good number of club sponsors and some new ones this season but are always looking for more.

We are very grateful for the sponsorship commitment to local grassroots rugby.

From the senior playing perspective, it was great to get promoted last season. The step up is a challenge, but one the

players are enjoying.

The 2^{nds} did well in their 1st season of league rugby and are currently sitting high in the league table.

The Colts did well last season especially as they were mainly a year young. All credit to Al, Stu, Boyd and Sarg for their

ongoing commitment to these boys and the club in general.

I must also thank Kieran as DoR, Kemps as Club Senior Coach and Andy as 1st team manager for their hard work.

Dave Walker stood down part way through the season as 2nd team manager and a very big 'Thank You' goes to him for his hard work and commitment in getting the 2^{nds} established. And thanks to Jay for stepping up and taking on that

role.

I think you will agree that with this team supporting Kieran, the playing side of the club is in a great place.

Thanks has to go also to our wonderful Ladies Team and what a successful season they had.

I must take the opportunity to mention our 3 current England Touch Internationals:

Cerys Godwin - u20s Maddie Miles-Kingston – u20s

Tilly Palmer u18s.

I look forward to seeing their international shirts on the wall in the club house.

Matt Jaynes is the England u35's men's coach and girls u18's coach.

We also have a number of Ladies representing the West Wildcats and Southwest Saxons Regional Squads ranging from u14's to u40's and Cerys represents the Midlands Tigers.

Also, the Ladies Squad won the Midland and Southwest Trophies again this year!

6. Junior Section Chairman's Report on the Junior Club's 2023/24 season – NH

This update will focus on end of 2023-24 success and where we are at as we get into 2024-25 season.

End of 2023-24 Season to note:

- We entered our first Colts team into the GRFU development league and were able to give a good showing. Most importantly we blooded 5 Colts players into senior rugby with Sam Wilson playing 1st team rugby.
- DPP success for 11 U16 players and 2 Academy players.
- We enjoyed competitive success with:
 - U16s making it to the semi-final of the County Cup.
- We held our End of Season awards ceremony with 180 + players in attendance with the U16s celebrating their final year as Juniors before they join the colts and hopefully senior rugby next season.
- The girls grew to 14 (from 4) and managed a few games as part of a hub of local teams.

Start of 2023-24 Season:

- 188 Players (and more to come) subs paid and on GMS. Including Colts with 17 more to pay = 205.
- 40+ Coaches.
- 12 teams: U6/7 to Colts (no U15 team) plus U14 & U12 Girls Teams.

Registration & Subs

• Great effort from coaches to get registration & subs organised. Pleased to say we are able to support 4 players this season through our financial support scheme.

Safeguarding & Welfare

- Arti Ranner has been doing great work in the Safeguarding and Welfare officer role.
- Incidents have been reported promptly and support offered as required.
- Including getting approval for 18 Colts players to play senior rugby this season.

• DPP

• Gloucester, Worcester and Wasps DPP catchment areas (6 counties) are now merged into one DPP - Gloucester. However, they do not have any additional resources and so have reduced age groups they support and selection is much harder.

Sites

Bredon

- Drainage solutions are clearly working and means we have been able to maintain 4 Junior Teams and the Colts sharing pitches on a Sunday.
- Ongoing thanks to Kathy and Kevin for ensuring players & parents are fed.

Westie

- Huge thanks to Matt Musto our incoming Vice Chair for managing the site & cafe.
- Work on the upper field has progressed well, delayed by an unusually wet spring and summer, but a massive thanks to Mark Frost and Tim Coppin for continuing to organise the work and providing their time and equipment. We have a flat field with grass. Fingers crossed we get some luck and can return fully next season.

7. Financial Report and Presentation of Accounts (Chair of Finance) – DT

NOTES

- Statutory/Financial Accounts not available to be presented but sharing Management Accounts, on which those are based.
- Expect very little difference in the two sets of accounts other than some accounting adjustments (e.g. timing, non-cash adjustments i.e. depreciation)

(reminder - this is a separate legal entity; the trading arm of the rugby club, with any surplus donated to the rugby club)

NOTES

- Turnover £73k; down -£2k YoY (down £8k vs 2yr ago)
- Cost of Sales was £51k (flat YoY) ... this is the cost of the products bought
- Gross Profit £22.5k

Cost however were higher

- Wages £16k +£5k YoY (more paid employees/few volunteers and inflationary cost e.g. NLW)
- Equipment Hire/Accountancy Fees (payroll)/Finance Costs flat YoY
- 2023 included £3.2k repair cost (replacement bucket chairs)
- 2023 includes Other Income (£5k) for Café reclassified/moved to Rugby Club.

NET PROFIT £2.2k, -£8k YoY

STAR INN @ BREDON LTD

Of the total sales, £48k/63% is draught beers, though sold 1,148 fewer pints YoY Bestselling:

- Inches 2,990 units
- Moretti 2,771 units
- Guinness 2,378 units
- Amstel 2,020 units
- Brixton 1,437 units

Also sold 1,234 crisps, 284 Baby Guinness and 317 Spice Rum and 194 Beckford Rum (since tagged as sperate item)

Of 10k transactions, 505 happened between 3pm-7pm (with a second push at 8pm) And highest average transaction is at 1am (£11.60)

Also gained £0.8k extra from charging non-member the higher prices (only from Jan'24)

Bredon Star RFC

Off the pitch, and despite successes and growth around the club and the various sections, it was another financially challenging year, not least driven by significant costs and investments, most notably delayed and back dated utility costs and pitch maintenance.

Revenue (Income)

- Total £72k from Membership/Subs, International Ticket Sponsors, Club Sponsors, donations and the Café. This includes £14k of Events income (shown gross but offset with -£13k of costs).
 - Membership ... £20k, of which 75% is from M&J, Men's £1.3k, Life £0.8k, Ladies £0.3k. YOY +£5.3k
 - Tickets Sponsors £10.3k
 - Sponsorship £5.7k ... some timing but lost sponsors in last 2-4 years
 - Café Income £7.5k (reclassed from Star Inn)

Also

- Advertising £1.9k; banners at Westmancote but offset with -£2.6k costs for scaffolding. This is a loss, partially recoverable from Cricket Club but written off in these accounts.
- o Grant Income & fundraising ... accounting adjustment / not cash; smooths profit for the income received to buy the building and spread over the life (opposite to depreciation)

Costs

How much does it cost to run a rugby team?

Running Costs of £38k pa (saving £12k YoY)

- Coaching Fees, Kit, Equipment ... replacement and new kit (not always funded)
- Referees, Competition/League Fees (increasing as now running Colts)
- Physio and First Aid (£4kpa ... higher YoY)
- Post Match Food (previously a hidden costs but highlighting here)

N.B. Not shown here is £1.3k of 'free drinks' post-match Man of the Match – not suggesting we stop that, only to highlight that it's not actually free.)

- Trophies and awards; one off/replacements, expected to last a few years
- N.B. Events Expenses (offsetting above income)

Gross Surplus £34k (47% of Turnover). However,

Overheads £62k pa

- Rent is £9k pa (flat YoY)
 - o Bredon Field £2k
 - Cricket Club £1.4k
 - Kemerton £2.3k

Use Boxing Day to raise funds and half raised goes back to the club?

Agreed. Encourage members to match fund raising with their employers.

Are we thinking about moving from Midlands to Gloucester?

Ongoing discussions. KF to better understand geographical limitations. To be raised at Exec committee.

KF closed the meeting by saying, this has been an encouraging season. We are still in a good financial position, although reducing costs and increasing revenue/sponsorship are our key drivers this season. The playing sides through the club are as strong now as ever and the social and community aspects of the club continue to shine through.
